

CAMP SIENNA

General Use Guidelines and Rules

Within the limits of Camp Sienna, it shall be unlawful for any person to do any of the following acts, except as may be otherwise provided:

1. To hitch, fasten, lead, drive or let loose any animal or fowl of any kind; provided that this shall not apply to dogs when led by a cord or chain, not more than six feet long. Animal waste is to be cleaned up by owner.
2. To allow animals on soccer and ball field play areas.
3. To drive any vehicle across the curbs, sidewalks, grass, lawn or anywhere else within park, other than roads, streets, parking lots, and designated park areas designated for that purpose.
4. To drive any vehicle carelessly, disregarding the rights or safety of others or without due caution and at a speed, or in a manner so as to endanger, or be likely to endanger, any person or property.
5. To park, or occupy more than one space, vehicles or trailers upon the grass, lawn or anywhere else within the park, other than those areas designated for that purpose.
6. To park any vehicle or trailer in any parking lot or parking area so as to obstruct, block or hinder ingress or egress of such parking lot or parking area.
7. To possess, carry, discharge, or have on premises any firecrackers, rockets, torpedoes, or any other fireworks, or air-guns or slingshots..
8. To damage, cut, break, injure, deface or disturb any tree, shrub, plant, rock, building, cage, pen, monument, fence, bench or other structure, apparatus or property; or to pluck, pull up, cut, take or remove any shrub, bush, plant or flower, or to mark or write upon, paint or deface in any manner, any building, monument, fence, bench or other structure.
9. To cut or remove any wood, turf, grass, soil, rock, sand, gravel or fertilizer.
10. To leave garbage, cans, bottles, papers, or other refuse elsewhere than in trash receptacles provided therefore. Bringing in outside garbage is prohibited.
11. To participate in any activity when the Sienna Plantation Residential Association Inc. (park management) or the Sienna Plantation Municipal Utility District No. 1 (park owner) believes such activity may create a danger to the public or may be considered a public nuisance. The SPRAI and SPMUD No. 1 Board may designate particular locations within park areas for specific activities.
12. To camp overnight in park, unless approved authorization by SPRAI.
13. To burn any type of matter or material in any area of the park, unless it is a controlled burning for the purpose barbequing using one of designated barbeque grills provided in the park picnic areas.
14. To consume alcoholic beverages.
15. To play or bet against any game which is played, conducted dealt or carried on with cards, dice or other device, for money, chips, shells, credit or any other representative of value, or to maintain or exhibit any gambling table or other instrument of gambling or gaming.

16. To use or speak any threatening, abusive, insulting or other language constituting “fighting words” in the park, and no person shall commit, in such park, any obscene, lewd or indecent act or create any nuisance.
17. To disturb in any manner any picnic, meeting, service, concert, exercise or exhibition.
18. To distribute, post, place or erect any advertising, handbill, circular, bill, notice, paper or other advertising devise.
19. To sell or offer for sale any food, drinks, confections, merchandise or services unless such person has a written agreement or permit issued by SPRAI.
20. To practice, carry on, conduct or solicit for any trade, occupation, business or profession or without approval of SPRAI.
21. To organize or participate in a “Special Event” as defined in the Camp Sienna Special Event Policy adopted by the SPRAI, in a manner inconsistent with that Policy.

SPRAI, as park management, reserves the right to grant exceptions to these above Guidelines and Rules by special permit.

Violation of any of these guidelines or rules related to parks will subject the violator to a fine of up to \$5,000 per violation or criminal penalties, including imprisonment, or both; punishable by the Municipal Utility District No. 1 through the Sienna Plantation Residential Association, Inc.
